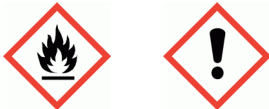

SECTION 4: First aid measures

4.1. Description of first aid measures

General information	If in doubt, get medical attention promptly. Show this Safety Data Sheet to the medical personnel.

Methods for cleaning up Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so.
